## Representative cases

### Dispute resolution

- In the case of an investment contract dispute between an investment management company and an electronic technology company, the two companies formed a large amount of debt during investment cooperation. The debtor, an electronic technology company, was a major shareholder of a listed company and held a large amount of restricted shares in the listed company. After accepting the entrustment of an investment management limited company, the agent successfully completed property preservation during the filing process, and the court sealed up a large amount of equity held by an electronic technology company in a listed company. After obtaining the successful judgment of the first and second instance of the case. During the period when an electronic technology company delayed the payment of its debts, the agent applied to the Beijing Intermediate People's Court for enforcement. Through efforts, the enforcement court sold some of the stocks that had been lifted, helping the client successfully recover all of its debts, such as the principal and interest of the huge debt
- Beijing Urban Construction Group Co., Ltd. and a real estate development company are in arrears with project payments. A real estate development company has been in arrears with Beijing Urban Construction Group Co., Ltd. for a long time.
