## Representative cases

### Non litigation

- Issue a special legal opinion on intellectual property rights for an app developed by a teaching technology company in Chongqing to assist in the company's financing development
- Provide legal compliance advice on emerging businesses for an agricultural technology company in Beijing, and provide decision-making reference for project implementation
- Issued a legal opinion for a venture capital company in Gongqing City and successfully registered as a private fund manager
- A lawyer's letter was issued for a coal mine in Ordos that was ordered to suspend production and sales, successfully leading the Energy Bureau to rectify its improper administrative behavior
- Provide legal services for a biotech company in Beijing to be subject to administrative penalties due to environmental issues, guide them in writing rectification reports, cooperate with interviews, and ultimately exempt from administrative penalties
- Served as a legal advisor to a health technology company in Beijing, resolving conflicts among startup teams, improving the distribution system, and assisting the company's compliance development

### Criminal action

- Acting as an agent in the case of a company's actual accuser suspected of misappropriating funds, through expert argumentation and a hearing by the procuratorate, to enable the handling authority to adopt our defense opinions, reduce the amount involved in the case, and strive for leniency and sentencing
- Acting as an agent in the case of a dangerous operation crime in Liaoning Fisheries, providing criminal defense for the principal offender, and successfully seeking to change the sentence and reduce the sentence in the second instance. This case involves a large number of people and has a significant social impact, which is a typical case of adding charges in the Criminal Law Amendment (11)

- Acting as the legal representative of a victim in a case where an investor was defrauded due to international education, successfully enabled the prosecution authorities and courts to adopt new evidence, increase the amount involved, and adapt the defendant's crime and punishment
- Acting as an executive of a company suspected of illegally absorbing public deposits. This case involves the event that depositors of rural banks in Henan were given a "red code", which has high social attention

### **Civil and Commercial Litigation and Arbitration**

- Acting as an agent in a contract dispute case between a decoration company in Beijing and the employer, claiming compensation from the liquidation obligor in the event of malicious cancellation by the other party was supported by the court to recover huge economic losses for the actual constructor
- Acting as an agent in a series of trademark use license contract disputes between a well-known chain coffee brand in Beijing and its franchisees to promote mediation, strive for a settlement scheme beneficial to the brand, obtain economic compensation, while maintaining the cooperative relationship between the parties, and resolve derivative disputes such as store management, equity transfer of affiliated companies
- Acting as an agent for a well-known football club in Jiangsu Province in a dispute over settlement fees with players, striving for a favorable change of judgment in the second instance to reduce huge economic losses for the club
- Acting as an agent in an arbitration case involving a dispute arising from the subscription of commercial ticket revenue rights for a technology company in Beijing, the arbitration tribunal adopted our agency opinion that "investment is actually a loan", ruling that the issuer should bear all payment obligations such as principal and interest, liquidated damages, lawyer's fees, and arbitration fees, in order to recover huge economic losses for the parties concerned
- Acting as an agent in a contract dispute case between a planning company in Beijing and an exhibition company. During the execution stage, an additional shareholder with the other party's ability to pay was added as the subject of execution, facilitating a settlement, reducing litigation costs for the parties, and obtaining full compensation in priority to other creditors
- Acting as an agent for a CCTV host in an infringement dispute with a well-known automotive company, seeking reasonable compensation for the parties, facilitating mediation, and avoiding negative public opinion due to the expansion of the incident
