- Acting as deputy mayor of a city in a bribery and abuse of power case
  - Acting as the party secretary and chairman of a bank's head office in accepting bribes and illegally granting loans
  - Sun Mou, a private entrepreneur, was not prosecuted for contract fraud involving 100 million yuan
  - Mei, a well-known internet company, was not prosecuted for alleged embezzlement
  - A private entrepreneur was sentenced to a suspended sentence for falsely issuing special VAT invoices
  - A private entrepreneur was sentenced to a suspended sentence for being suspected of illegal business operations
  - Zhu, the head of a financial institution, was suspected of rape and refused to be arrested
  - Wang, a senior executive of a private enterprise, is suspected of colluding in bidding and is not approved for arrest
  - Zhao is suspected of illegal medical practice and is not authorized for arrest
  - Wang Ying is suspected of organizing or leading pyramid selling activities and is not authorized for arrest
  - Li was suspected of obstructing the prevention and treatment of infectious diseases and was transferred to administrative punishment
