### Representative cases

- Li Mou in Beijing was charged with the crime of forging company seals and the crime of covering up. He was charged with two main

crimes and ultimately refused to prosecute;

- Li Moumou in Beijing was suspected of obstructing the prevention and treatment of infectious diseases, and the criminal case was dismissed and turned into administrative punishment;
- Liu and others in Beijing are suspected of organizing and leading pyramid selling activities, and are not allowed to be arrested;
- Chen Mou in Beijing is suspected of falsifying special VAT invoices, revoking the arrest decision and lifting the mandatory measures;
- Zheng Moumou, Anhui Province, is suspected of contract fraud and is remanded for retrial in the second instance, with a mitigated punishment;
- 26 people including Xie Moumou, an entrepreneur in Jiangxi Province, organized, led and participated in criminal organization, crime of usury on loan, crime of forced transaction, crime of evading capital, and several crimes will be given lighter punishment;
- In Henan Province, Zhang is suspected of two crimes, namely, bribery and duty embezzlement, involving non-state personnel. The bribery of non-state personnel will not be prosecuted, and the amount of duty embezzlement will be reduced;
- In a case involving three crimes, namely, the crime of illegally transferring land use rights, the crime of fraud, and the crime of transferring land use rights at high interest rates, the court did not recognize the crime of illegally transferring land use rights, and reduced the amount of the crime of fraud by more than 10 million yuan;
- Sui, Hebei Province, was convicted of another misdemeanor in connection with rape, robbery, and illegal detention;
- Beijing entrepreneur Ye Mou is suspected of polluting the environment and will not be prosecuted;
- Tang Moumou, suspected of arson in Beijing, was sentenced to a suspended sentence;
- The vice mayor of a city in Jiangsu Province is suspected of accepting bribes, abusing his power, and bending the bill for personal gain;
- The case of bribery and illegal loan issuance by the party committee secretary and chairman of the head office of a bank in Henan Province;
- Yang Mou in Beijing is suspected of the crime of abuse of power by personnel of state-owned institutions;
- Liao Mou in Liaoning Province is suspected of falsely issuing special VAT invoices (involving an amount of over 2 billion yuan);
- Yang Mou in Henan Province is suspected of corruption;
- A dispute case involving a copyright license contract between a technology limited company in Beijing and a technology limited company in Shenzhen.
