### Settlement of civil and commercial disputes

- The types of civil and commercial dispute resolution cases represented by Lawyer Chen mainly include: equity transfer disputes caused by performance gambling, private lending disputes, advertising contract disputes, housing sales contract disputes, franchise contract disputes, and property preservation damage liability disputes
- Acting as an agent in the arbitration of equity transfer disputes between a capital management company and Ye X and a holding limited company due to gambling, mediating and settling the case, and collecting all payments
- Agent client sued a group company for neighboring relationship dispute, winning the lawsuit, and the payment has been collected
- Acting as an agent for a film company in a series of contract disputes involving multiple movie studios' cancellation and liquidation, bankruptcy, and third-party debt accession, as well as litigation/arbitration procedures
- Acting for a company to respond to Zhang X's application for property preservation damage liability disputes, minimizing the client's losses
- The case of agency client suing a medical company and Xiao X's private loan dispute involves inheritance, limitation of action, private loan, defendant 2's failure to register equity pledge in accordance with the agreement, and other facts. After the agent collected evidence from multiple parties and developed a complete response plan, the court ultimately supported our lawsuit request that the client require defendant 2 to assume partial liability for compensation
- The first instance of the agency client's lawsuit against a company's private loan dispute and the labor dispute between the two parties have been settled through mediation, and all payments have been collected
- The agent client responded to the case of Guo XX and Chu XX housing sales contract dispute, winning the lawsuit, and the court rejected all the other party's claims
