## Representative cases

- In 2012, Nanjing's first drug trafficking case was amended to apply criminal technical investigation
- In 2013, Unicom Jiangsu Branch sued a company in a service contract dispute (criminal and civil intersection), and successfully won the case on behalf of the defendant company (the court rejected all of Unicom's claims)
- In 2015, Wang was suspected of defrauding 2 million yuan, and the Nanjing Pukou Procuratorate did not prosecute the acquittal
- In 2016, Yang and others deliberately killed people, and finally avoided death
- In 2017, Cao sold drugs and allowed others to take drugs, and the Nanjing Municipal Procuratorate did not prosecute a case of acquittal
- In 2018, Cao was sentenced to a suspended sentence for assaulting a police officer for obstructing official duties
- In 2019, a certain Maotai liquor futures fraud of 10 million yuan in Maotai liquor futures in Zaoyang, Hubei Province, was sentenced to fixed-term imprisonment for life and imprisonment
- In 2019, Nanjing Yu Moumou was acquitted without prosecution for the crime of manslaughter
- In 2020, 28 people including 4.29 Peng Mouyou of Lu'an City, who represented the Anhui Provincial Procuratorate Office, were involved in a major criminal case
- In 2021, the fraud case handled by Huang was withdrawn by defense

## Awards

In 2015, he was awarded the title of "2013-2015 Outstanding Public Welfare Lawyer" by Nanjing Municipal Bureau of Justice

In August 2016, he won the second prize in the writing group of the first Young Lawyers Practicing Skills Competition held by the Nanjing Lawyers Association in 2016
