  - Li Mougou's copyright infringement case (the court of second instance revoked the first-instance sentence and only imposed a fine)
  - The case of Yuan's crime of organizing prostitution (at the stage of nuclear arrest, the characterization was changed from the crime of organizing prostitution to the crime of assisting in organizing prostitution)
  - Yang Mougou's crime of illegally absorbing deposits from the public (suspended sentence by the court)
  - Zhang Mougou suspected of intentional homicide case (case more than 20 years ago, review prosecution stage, not prosecution)
