Representative cases

Civil action

- Acting plaintiffs Wang and Jiao were selected as typical cases in Jiangsu Province for excluding nuisance disputes and were published in Jiangsu Legal Daily
- Acting as an agent for the defendant, a real estate company in Jiangsu, in disputes over sales contracts for commercial housing with over 200 owners, and recovering tens of millions of losses for the defendant company

Criminal action
